Voice Referendum, Don Farrell & the Fraudulent Writ.

A fraudulent writ actually *disqualifies* voting. This is a revelation to the Australian public. You may be just learning about the fraud. What are your options? Once you're satisfied there's a fraud, you cannot participate in a crime and in fact, you're obligated to report it.

Options

If you're not yet sure what you must do, there are 4 possible options as follows:

- 1) Vote 'Yes"
- 2) Vote "No"
- 3) Not Vote (ask for accountability re existing fraudulent writ, duty to report a crime).
- 4) Vote BUT you must now do your own research (see docs below). Look at the writ & legislation. Ask questions about the writ. Join a revelation group to expose the corruption.

This last option leaves it open for anyone who votes (either way) to start the process. Folk can still go to the polling booth, do their research; ask about the writ, collect the name of the polling booth manager, make AEC staff aware and accountable. Remember, they serve you the elector. Take further action later.

Here are some resources to help you understand the deception and how you can expose it.

- Ask Don Farrell. A document calling for accountability from Don Farrell.
- Attention the Voting Booth Manager (Copy of actual writ published on the AEC website).
- Copy of the Referendum (Machinery Provisions) Act 1984 S1 Forms (What the legislation stipulates).

Suggested Action Steps – Voting Day

- 1. Attend AEC Polling Booth on 14th October 2023.
- 2. Prepare to collect your evidence: take a pen, charged mobile phone (to record audio). Attend with witnesses to observe and share your experience.
- 3. Ask for the name of the **polling booth manager** (before you get your name crossed off the register if you're voting). Collect names of any other staff you speak to.
- 4. Ask to see a **copy of the valid referendum writ**. The most likely scenario you'll be told it's not kept on the premises/it's on the website. Ask questions e.g., Why it looks different? Who is Don Farrell?
- 5. **If not voting:** Don Farrell has "disqualified my vote" and state you require this to be recorded. Produce your copy of the writ showing the fraud and use it as a tool i.e., polling booth manager name and ask them to sign (most likely they'll refuse).
- 6. Assert your need for the polling booth manager to take your name, address to report back that you attended the polling booth station on the day.
- 7. Prepare for push back. Be polite/assertive. Let AEC reveal themselves.
- 8. At polling booth/asap, take notes on names, time and everything that happened.
